For this event, we are requesting a suggested voluntary contribution of £2-£3 per child. Any contributions may be paid via your ParentPay account, via the 'Parental Voluntary Donations' payable item. All children will have the opportunity to participate, regardless of whether or not parents/carers have contributed.

We are also asking for donations of any new or nearly new teddies from Year 6 pupils only. These teddies will be used in the 'Guess the name of the teddy' game.
